#### Weekends and Holidays

No matter which season, on weekends and holidays the following rates are in effect. <u>View the Holiday Schedule for Time-of-Use and Ultra-Low Overnight</u>.

This means:

- For **TOU** Off-Peak
- For **ULO** Weekend Off-Peak and Ultra-Low Overnight

**Note:** If a holiday falls on a weekend, the next weekday (that is not also a holiday) will have the holiday prices in effect all day.
